Mill Valley is the caterer of record for all Trailhead events, with right of first refusal. In the event that Mill Valley exercises that right, an approved outside caterer may be used, with a fee of 12.25% of the final catering invoice payable to the Loppet Foundation, to be collected at time of invoicing. The one exception to this rule is for cultural considerations. The Loppet Foundation will waive the 12.25% fee if an outside caterer is used for cultural considerations.

Any and all alcohol for an event must be purchased through Mill Valley, regardless of caterer.
